

Yeshiva Shaarei Menachem Tesla Raffle 2026 — Official Rules & Regulations: Yeshiva Shaarei Menachem Inc. (“Sponsor”) is responsible for administering this raffle (the “Raffle”) and all related decisions, which are final and binding. By purchasing a ticket or submitting a free entry, each entrant agrees to read, understand, and abide by these Official Rules and all decisions of Sponsor. The Raffle begins upon Sponsor’s official launch announcement and ends at the stated closing date/time in the launch message and accompanying promotional materials (the “Entry Period”). The Grand Prize drawing will be held on February 6, 2026 (or on a rescheduled date announced by Sponsor if necessary). One (1) winner will be selected at random from all eligible entries received during the Entry Period. The winner will be notified using the contact information provided (phone, email, or text) within twelve (12) business days following the drawing. If Sponsor is unable to contact the winner within thirty (30) days of the initial notification attempt, the prize will be deemed unclaimed and Sponsor may, at its discretion, select a new winner at random from remaining eligible entries. Eligibility: Entrants and winners must be 21 years of age or older at the time of entry and must be legally eligible to participate under applicable law; void where prohibited. Sponsor reserves the right to verify eligibility and may require additional information and documentation, may deny entry to any person, and may cancel and/or revoke any entry at any time without notice if Sponsor believes there is a violation of these rules or applicable law. How to Enter (Paid Entry): Tickets are \$100 per ticket unless Sponsor offers a promotional discount; Sponsor may run limited promotions (for example, 2 tickets for \$100) during promotional periods as communicated by Sponsor; ticket purchases are final and non-refundable unless Sponsor states otherwise in writing. No Purchase Necessary (Free Entry / AMOE): To enter without purchase, mail a handwritten 3”x5” card with your full name, age, phone number, email address, and mailing address to Yeshiva Shaarei Menachem Inc., Tesla Raffle AMOE; mail-in entries must be received by Sponsor by the Entry Period closing date/time stated in the launch message; limit one (1) free entry per outer envelope unless Sponsor states otherwise; incomplete, illegible, or late entries are void. Prize / Winner’s Choice: The winner will have the choice to receive either (a) one Tesla Model 3 Rear-Wheel Drive (base model) or the closest equivalent base Model 3 configuration available at the time of purchase, or (b) \$28,000.00 USD (cash option). If the winner chooses to customize the Tesla beyond the base Tesla Model 3 Rear-Wheel Drive specifications, the winner is responsible for any additional costs, options, upgrades, taxes, and fees. The prize is non-transferable; no substitution or cash equivalent is permitted except that Sponsor reserves the right to substitute a prize of equal or greater value if the stated prize becomes unavailable, delayed, or impractical to provide. Claiming the Prize / Required Documents: To claim the Tesla prize, the winner must present a valid driver’s license, Social Security Number (or equivalent), and proof of insurance, and must complete any required tax forms (including a W-9 if applicable); to claim the \$28,000 cash prize, the winner must present a government-issued ID and Social Security Number (or equivalent) and complete any required tax forms; Sponsor may withhold the prize until verification is complete to Sponsor’s satisfaction. Taxes / Costs: All taxes and government fees of any type (including federal, state, local, sales, and withholding taxes), and any additional costs not explicitly included in the prize as awarded, are the sole responsibility of the winner; for the Tesla option, this includes, without limitation, insurance, licensing, registration, title fees, destination charges, and any options beyond the base configuration; the winner is encouraged to consult a tax advisor regarding tax consequences and reporting obligations; odds of winning

depend on the number of eligible entries received. Publicity Release: Where permitted by law, entrants and winners consent to Sponsor's use of their name, likeness, photograph, and/or statements for publicity and promotional purposes without additional compensation. Governing Law / Disputes / Arbitration: These Official Rules are governed by the laws of the State of New York; any controversy or claim arising out of or relating to the Raffle or these Official Rules shall be resolved by binding arbitration administered by the American Arbitration Association (AAA) under its Commercial Arbitration Rules (including expedited procedures where applicable), conducted in New York County, New York; judgment on the arbitration award may be entered in any court of competent jurisdiction, and the exclusive venue for confirming an arbitration award shall be the state and federal courts located in New York County, NY. Disclaimers / Limitation of Liability: Except as expressly stated herein, Sponsor and its agents, directors, employees, officers, and representatives make no representations or warranties regarding any prize, including any implied warranties of merchantability or fitness for a particular purpose, all of which are hereby disclaimed to the fullest extent permitted by law; Sponsor is not responsible for lost, late, misdirected, damaged, incomplete, illegible, or delayed entries, or for any technical, human, or other errors; to the fullest extent permitted by law, Sponsor and its related parties shall not be liable for any indirect, incidental, special, or consequential damages; Sponsor's total liability to any participant shall NOT exceed the amount paid by that participant for raffle tickets (if any), without interest; participant agrees to indemnify and hold Sponsor harmless from any loss, damage, or expense incurred by Sponsor arising out of participant's actions or omissions, including those of participant's agents, family, employees, and guests. Additional Restrictions: Employees of Tesla, Inc. (and its affiliates) are ineligible to participate; Tesla and Tesla model names and logos are trademarks of their respective owners; this raffle is not sponsored, endorsed, administered by, or affiliated with Tesla. Rule Changes: Sponsor reserves the right to modify these Official Rules at any time, in its sole discretion, including to comply with applicable law or to address administrative needs, and any updates will be effective upon posting or distribution in Sponsor's official communications.
